# Challenges and opportunities for outbound investment in the US from the legal perspective

### Challenges – overview of governmental entities

- MOFCOM (Ministry of Commerce)
- NDRC (National Development and Reform Commission)
- SAFE (State Administration of Foreign Exchange)
- SASAC (State-owned Asset Supervision and Administration Commission) when dealing with stateowned enterprises under its direct supervision

### Opportunities – increased interest supported by governmental policies

- Both public and private sectors have been urged to acquire new technology and market share abroad
- 12th Five Year Plan (2011 to 2015) encourages strategic industries

# **Evaluating interested parties from the PRC**

### • Who are they?

- SOEs
- Private enterprises (are they already listed on an established stock exchange?)
- A consortium with a PRC entity as a party

# Evaluating interested parties from the PRC (cont.)

### • Do they have experience?

- Outbound investments
- Industry
- International operations
- Familiarity with PRC regulations

## Evaluating interested parties from the PRC (cont.)

### How are they paying?

- SOEs have tended to use domestic funding or pay entirely with cash
- Private entities may consider more financing alternatives
- Is the money already offshore? If not then SAFE approvals will also be necessary in addition to MOFCOM, NDRC and SASAC (if needed)
